1. Introduction

The European Commission (hereafter 'the Commission') is committed to protect your personal data and to respect your privacy. The Commission collects and further processes personal data pursuant to <u>Regulation (EU) 2018/1725</u> of the European Parliament and of the Council of 23 October 2018 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data (repealing Regulation (EC) No 45/2001).

This privacy statement explains the reason for the processing of your personal data, the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

The information in relation to processing operation of the contact points of WebECURIE system undertaken by DG.ENER.D3 is presented below.

2. Why and how do we process your personal data?

<u>Purpose of the processing operation</u>: DG.ENER.D3 collects and uses your personal information to alert and exchange information with and between the Competent Authorities in the Member States in case of a radiological emergency (or exercise). This exchange takes place through the ECURIE system. ECURIE users have been appointed by their organization and should create an EULogin account before being allowed to access the WebECURIE system. 3. On what legal ground(s) do we process your personal data

We process your personal data, because (art 5(1)(a) of Regulation (EU) 2018/1725): processing is necessary for the performance of a task carried out in the public interest by the EU institution.

The legal basis of the processing has been laid down in the Council Decision 87/600/Euratom of 14 December 1987.

We do not process special categories of personal data, therefore Article 10 of Regulation (EU) 2018/1725 does not apply.

4. Which personal data do we collect and further process?

In order to carry out this processing operation DG.ENER.D3 collects the following categories of professional and private contact personal data :

- Name;
- Surname;
- E-mail;
- Telephone;
- Organization;
- Role;
- Office address.

We have obtained your personal data from your Competent Authority. You have been appointed by your organisation and an account was created to allow your access to the WebECURIE platform. If you need more info about the collection of your personal data, please ask your organisation that appointed you.

5. How long do we keep your personal data?

DG.ENER.D3 keeps your personal data for the time necessary to fulfil the purpose of collection, retention period in line with "COMMON COMMISSION-LEVEL RETENTION LIST FOR EUROPEAN COMMISSION FILES-SECOND REVISION, point 6.6", nuclear liabilities 99 years. Data updates are performed as necessary based on information collected systematically. ECURIE Member States can add and modify their own users. A review of the database is carried out every year.

6. How do we protect and safeguard your personal data?

All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored on the servers of the European Commission. All processing operations are carried out pursuant to the <u>Commission Decision (EU, Euratom) 2017/46</u> of 10 January 2017 on the security of communication and information systems in the European Commission.

The Commission's contractors are bound by a specific contractual clause for any processing operations of your data on behalf of the Commission, and by the confidentiality obligations deriving from the transposition of the General Data Protection Regulation in the EU Member States ('GDPR' <u>Regulation (EU) 2016/679</u>).

In order to protect your personal data, the Commission has put in place a number of technical and organisational measures in place. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.

7. Who has access to your personal data and to whom is it disclosed?

Access to your personal data is provided to the Commission staff responsible for carrying out this processing operation and to authorised staff according to the "need to know" principle. Moreover, access is provided to IAEA and all Competent Authorities in the ECURIE member states having access to the WebECURIE platform.

In addition, the processor AlarmTILT has access to your personal data (phone number) to enable the automatic call-out service to notify you in case of radiological emergency (or exercise).

The controller will transfer your personal data to the following recipients in third countries outside the EU and EEA i.e.: respective officials of competent national authorities of ECURIE member states like Montenegro, North Macedonia, Serbia, and Switzerland and to respective officials of the international organisation IAEA in accordance with Regulation (EU) 2018/1725. The controller will transfer your personal data based on:

- Article 47 of Regulation (EU) 2018/1725- adequacy decision of the Commission for Switzerland
- Article 50.1 (d) of Regulation (EU) 2018/1725- transfer is necessary for important reasons of public interest (Montenegro, North Macedonia, Serbia)

The information we collect will not be given to any third party, except to the extent and for the purpose we may be required to do so by law.

8. What are your rights and how can you exercise them?

You have specific rights as a 'data subject' under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access, your personal data and to rectify them in case your personal data are inaccurate or incomplete. Where applicable, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing, and the right to data portability.

You have the right to object to the processing of your personal data, which is lawfully carried out pursuant to Article 5(1)(a) on grounds relating to your particular situation.

You can exercise your rights by contacting the Data Controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor. Their contact information is given under paragraph 9 below.

Where you wish to exercise your rights in the context of one or several specific processing operations, please provide their description (i.e. their Record reference(s) as specified under paragraph 10 below) in your request.
